## Program Overview

## Submission requirements

Submissions must be made by email **no later than 5.00pm on Friday 1 October** (no submissions will be accepted beyond this date).

Both Word and PowerPoint format are accepted.

To be considered, your submission **must** include:

1. A clear statement of the aim and objectives of the presentation (approx. 200 words)
2. A biography (including qualifications)
3. An indication of what level your presentation is aimed at within the industry (ie: coordinator, Senior, Management) and also what type of professional position (ie: in-house, PCO, Audio Visual, Themeing, production, venue, sales, etc).

### NOTE:

- Speakers must be available to present at any time from Sunday 17 April through to Tuesday 19 April, 2011 for approximately 45 minutes.
- All confirmed speakers will be responsible for their own travel and accommodation costs unless otherwise agreed to by MEA.

## Education Level

To ensure your presentation is PD compliant, please consider:

- **Context** – is the content written in a context specific to Meetings & Events Industry?
- **Education level** – is the content beyond the minimum education requirements and preferably, suited to the needs of a professional?
